APPOINTMENT OF EXECUTIVE DIRECTOR AND QUALIFIED ACCOUNTANT

The Board of Directors (the “Board”) of IDT International Limited (the “Company”) announces that Dr. Eva Lam Yee Wah (“Dr. Lam”), has been appointed as an executive director and a qualified accountant of the Company with effect from April 1, 2008.

Dr. Lam, aged 48, joined as the Group Chief Financial Officer of the Company since November 2007. She has over 25 years experience in financial management and expertise in various aspects including auditing, group management accounting, company secretarial services and strategic mergers and acquisitions. Dr. Lam is a Fellow Member of The Hong Kong Institute of Chartered Secretaries (HKICS), a Fellow Member of The Hong Kong Institute of Certified Public Accountants (HKICPA) and also a Fellow Member of The Association of Chartered Certified Accountants (ACCA). She holds a Doctorate degree of Business Administration from The University of Newcastle, Australia, an Executive Master degree of Business Administration from The Chinese University of Hong Kong and a Professional Diploma in Accountancy from the Hong Kong Polytechnic University. Prior to joining the Company, Dr. Lam had worked in the Telecom Industry for over 21 years, first started with Hong Kong Telecom Group (now PCCW) holding various positions. Her last position was the Chief Financial Officer and Company Secretary of CSL (New World) Mobility Limited. Dr. Lam did not hold any directorship in any listed public companies in the last three years.

A service agreement has been entered into between Dr. Lam and the Company for a period of 3 years commencing from April 1, 2008 which is determinable by the Company by giving three months’ notice in writing. Dr. Lam will be subject to retirement by rotation and re-election in accordance with the Bye-laws of the Company. She is entitled to a director’s fee of HK\$ 50,000 per annum subject to any adjustments as the Board considers appropriate by reference to the prevailing directors’ fees for directors of listed companies in Hong Kong and subject to the approval of the shareholders at annual general meetings of the Company.

As at the date of this announcement, Dr. Lam has personal interest in 3,000,000 share options of the Company. Save as disclosed herein, she does not have any interest in the shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance. Other than the relationship arising from her being appointed as an executive director and a qualified accountant, Dr. Lam does not have any relationship with any directors, senior management, substantial shareholder or controlling shareholder of the Company. Dr. Lam has confirmed that there is no information that needs to be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited.

The Board is not aware of any other matters in relation to the appointment of Dr. Lam as an executive director and a qualified accountant that need to be brought to the attention of the shareholders of the Company and would like to take this opportunity to extend a warm welcome to Dr. Lam for joining the Board.
